## 5. Discussion Items

# A. Discussion Regarding the Selection of Officers for 2022

#### 6. Comments and Updates by the Elected Official or Agency Representative

- A. City of Banning Art Vela reported that the Banning City Council assigned David Happe as the new representative from the City of Banning. Kyle Pingree will remain as the alternate.
  - The City is assembling its education campaign on water conservation, and is modifying its own use such as landscaping irrigation, he advised.
- B. Banning Heights Mutual Water Company Absent.
- C. Beaumont Basin Watermaster Mr. Vela reported that the Watermaster would soon be working on developing an outline for a series of workshops related to basin management strategies and consistency with the adjudication.
- D. Beaumont Cherry Valley Water District Daniel Slawson reported that the District is working on a \$7.5 million Line 16 storm drain project with Riverside County Flood Control to divert stormflow to the recharge system. Grant funding has been obtained, and construction should begin in March 2022, completed in June 2023. Jaggers added that preliminary grading has begun, but the holdup is materials acquisition.

Slawson also noted that District staff has worked hard on the burn scar area from the El Dorado and Apple fires, successfully averting damage from mud and debris flow. BCVWD General Manager Jaggers added detail on the December 14 and 26 storm events and commended the partnership and mitigation work of Flood Control. Jason Uhley added that work is not over yet – muddy water will continue to be seen for a while. He acknowledged the partnership of BCVWD and the school districts and other agencies.

Slawson advised that the District will be redrawing its division boundaries per the 2020 U.S. Census data, and public hearings will be held.

- E. Cabazon Water District Diana Morris indicated that the District is awaiting the assignment of a new Board member by the County of Riverside. At that time, the representative positions will be assigned.
- F. City of Calimesa Wynona Duvall stated that the City's current focus is on the Housing Element draft document. She provided an update on commercial development.
- G. High Valleys Water District Stan Houghton advised that Director Mona Vansickle had resigned and there will soon be two vacancies on the Board. He advised that Riverside County is considering establishing off-road vehicle parks. Two of the suggested locations are adjacent to High Valleys facilities, which would have an impact on the District area and water. He noted some concerns.

Mr. Vela said he had heard about it; Mr. Houghton directed the group to the website with relevant documents. Mr. Uhley noted this is the front end of the process and they are trying to daylight potential issues on the six sites and

determine which is most likely to succeed. Comments can be sent to Kyla Brown in the Parks Department, he advised, and offered to provide the Alliance with the links and with Ms. Brown's phone number.

- H. Mission Springs Water District Absent.
- I. Morongo Band of Mission Indians John Covington noted that the Tribe also has many things going on. He noted moderate flooding and damage on the reservation after the two storm events; mitigation is ongoing. Expenditure of the ARPA funding allocated to all federally-recognized tribes is in progress, he noted; at least 1/5 of which will go to water and wastewater projects. He indicated that 2022 will be a year of moving forward capital improvement projects.

Covington advised that there is money available in the federal Infrastructure bill passed in 2021 for regional water management and drought projects. The tribe is building an internal coalition, he said, but offered that if there is opportunity for joint multi-benefit, multi-use projects at a regional level to bring them back for discussion at this forum.

Covington advised of the realignment of Hathaway Street and the relocation of the Indian Health Clinic. In response to Covington, Vela provided an update on the Hathaway project.

- J. Riverside County EDA / Flood Control District Jason Uhley advised there was a lot of erosion downstream of the Brookside Bridge, and Flood Control is applying a significant amount of rock in the area to protect the bridge and keep the channel in place. The project will be ongoing for several months, he noted.
- K. San Gorgonio Pass Water Agency Larry Smith reported that he is now the Agency president, Mickey Valdivia is the vice president, and Director Letulle is the Treasurer.

Mr. Smith acknowledged the comments of Mr. Jaggers and Mr. Covington at the retirement of Director Steve Lehtonen.

The appointment process is ongoing, and redistricting has started, Smith noted. He advised there is much action forthcoming. Mr. Jaggers noted that SGPWA General Manager sent out a notice that the original State Water Project allocation of zero has been increased to 15 percent.

- L. South Mesa Water Company Absent.
- M. Yucaipa Valley Water District Joyce McIntire indicated that the District is getting closer to drilling the injection wells and reported on current status.
