- Coordination & fairness of building density current & future customers
- Incorporate new technology
- A diversified water supply

How do we get there, what needs to be done?

1. **Diversity of supply** – purchase of all affordable Table A Water
 - A. Conservation (new technology on plumbing locations)
 - B. Educate the public
2. **Recycle** - i.e. gray water, dual plumbing, package septic systems in new developments.
3. **Agency Partnerships**
 - A. True communication between agencies
4. **Protect current sources**
 - A. Flume
 - B. Capture leakage to other areas
 - C. Utilize all sources and resources

5. Maintain/build infrastructure

A. Capture storm water (reservoirs, basins)
