#### 1. Call to Order - Roll Call

#### 4. Review Budget and Financials

In the absence of Riverside County Flood Control, Mr. Jaggers indicated that it does not seem that the Alliance is currently spending any money. BCVWD is providing minute-taking and agenda preparation at this time as part of the partnership and has submitted no expenses. He recalled that the account may contain \$10,000 to \$15,000.

Mr. Vela reminded the members about the comments of Juliana Adams from Riverside County Flood Control at the last meeting, and that she was going to bring back information to this meeting.

Chair Slawson tabled the item to the next meeting.

#### 5. Discussion Items

#### A. Beaumont Basin Watermaster report

BBWM Chairperson Art Vela reported:

• Held a workshop on July 13 focused on groundwater management

- o Production from the adjudicated basin
- Storage accounts
- Possibility of delineating the basin into two areas
- Suggestion to look at structure from the Groundwater Sustainability guidelines as a possible management strategy
- Next meeting on August 2

#### B. San Gorgonio Pass Water Agency activities update

Mr. Lance Eckhart, SGPWA general manager, reported on the following:

- Held an important tax rates meeting and stayed the ad valorem tax rate at 17.5 percent which covers:
  - Restricted fund for bond payments on the State Water Project, East Branch extension
  - Balloon payments are coming up and reserves are positioned to pay those down
  - SWP administrative overhead
  - State Project Water exchanges with other contractors
  - SWP repairs
- District is in a good position not to raise taxes
- Delta Conveyance (tunnel) is moving forward slowly
- Governor Newsom pushing forward larger projects with executive orders
- Ventura Water long term lease for their SWP share increased the SGPWA water supply portfolio for the next 20 years (after that, Sites Reservoir should be online)
- Met this week with Sites Reservoir representatives to talk about next steps including signing contracts for bonds
- Major changes in 2023-2024:
  - Local development continues strong
  - o 100 percent hydrology (expect higher highs and lower lows)
  - SWP costs are increasing
- San Gorgonio median house prices have increased but there has been a small drop in the last few months but development is continuing strong
- (there is still a housing crisis here)
- Highest growth area in property values from FY 2020-21 and 2021-22 in Riverside County; trending west to east
- An increase in the ad valorem tax might be prudent given the reliance on imported water and the knowns and unknowns being faced
- Costs are expected to increase for Sites, the Delta tunnels, and Department of Water Resources (DWR) infrastructure
- Recent revenues have been offset by recent inflation
- Funding of Sites with ad valorem
  - o Ongoing issue; different methods are being used to pay in
  - Possibility of partnering with DWR and Sites to put costs on the Statement of Charges to be able to use restricted funds
  - o Sites restores the original SWP projection and what has been paid for
  - Will be decided in the next few months

- Water conditions: Catch the wet years while possible; dry years are coming
- Reservoirs are full, everyone is looking for places to store water in the ground
- Farmers are recharging water rather than growing crops
- Reviewed the water portfolio
  - o 34,000 acre-feet (af) in the system
  - Trying to bank 20,000 af locally, but it looks like there will be some left in the San Luis Reservoir
  - Article 21 water available
- Maintenance performed on recharge ponds to keep them at full capacity until recharge rates slow
- Recharged just under 12,000 af so far this year

Mr. Jaggers added that snowmelt is continuing to feed the reservoirs.

#### C. Current status of water supply / drought and related activities

Mr. Jaggers noted that it has been a wet year in the south which has created a condition that retail water usage compared to last year is significantly less. This is bad for revenue but great for catching up. BCVWD is off approximately 22 percent of sales as of the end of June compared to last year. Local water managers are working on collecting data sets necessary to work together as a region.

Mr. Eckhart stressed the importance of having the financial wherewithal to pay for the water when it is available. Jaggers concurred and recommended setting funds aside in the dry years to fund the wet year purchases.

Mr. Slawson reported attending a webinar at which he shared local area successes but was followed by representatives from northern California commenting on the continued presence of grass yards and lack of rain gutters on roofs. He expressed hope for Sites and the tunnel.

#### D. Grant opportunities and funding

Mr. Eckhart reported working with HOAs (Sun Lakes, Solera, Four Seasons) on a pilot program and grant application for large scale turf replacement. Starting these types of programs will be a long-term process, he noted.

The Countyline Road recharge grant application was not successful, Eckhart stated. Other sources are being sought, as the project is almost shovel-ready.

Eckhart reported on the SGPWA pilot program to provide gap funding for small agencies to facilitate grant projects. Other agencies have inquired. He noted other projects in progress and said the SGPWA voted to offer gap funding.

Grant funds for a few USGS monitoring wells in east Banning / Cabazon were received through the SGMA grant process, Eckhart said.

More federal grant opportunities are coming forward, he noted. Consulting firms can point in the right direction.

#### E. Legislative Report: None.

Mr. Jaggers advised of a Notice of Proposed Rulemaking from the State Water Resources Control Board on Hexavalent chromium (Chrom-6) maximum contaminant levels (MCL) which will affect local purveyors. It appears the State is going back to 10 parts per billion.

Mr. Vela agreed this is challenging, as there is a major capital and operating price tag for building treatment facilities to comply with the new standard. Like the last tie the State tried this, there is much debate regarding the standard and the State's considerations. The State is not giving water agencies a lot of time to comply, he added. To generate the revenue needed to build treatment facilities could require a Prop 218 rate adjustment. The EPA looked at their standard of 100 ppb and did not find reason to change it, he said.

The potential PFAS standard will have a cost for compliance and will be another issue for water agencies to confront, Vela noted.

Mr. Jaggers pointed out that the Chrom 6 is naturally forming in the geological formations. He estimated that 40 to 50 percent of BCVWD wells would be adversely affected.

Mr. Vela and Mr. Jaggers discussed the Chrom 6 treatment technology, costs, and the resultant hazardous waste.

  - The 2x2x2 Recycled Water committee including BCVWD, SGPWA and the City of Beaumont has been collaborating
  - The recent fires came close to facilities but caused no infrastructure issues
  - The highest production from the recommissioned reverse osmosis facility occurred this month
  - The Mesa Lift Station upgrade project is underway and going to bid soon
  - The Santa Ana Watershed Project Authority (SAWPA) is entering a master plan study. Now is the time to consider connecting to the Brine Line

- D. Beaumont Cherry Valley Water District Daniel Slawson and Dan Jaggers highlighted:
  - Dedication for the MDP Line 16 stormwater recharge project is scheduled for Sept. 7
  - Working to move projects forward
  - Currently recharging a lot of water and working with the SGPWA
  - A request was received today from ACWA for agencies to do energy loadshedding today / conserve electricity on hot days
- E. Cabazon Water District Taffy Brock reported:
  - Working on getting Well 1 pump back online after failure
  - Cleaning and construction on tanks
- F. City of Calimesa No report
- G. High Valleys Water District Stan Houghton and Sam Hughes reported:
  - Locators to be installed for the aerial survey beginning the pipeline project
  - Rate study underway with the help of the SGPWA interest in ratepayer acquiescence
  - Finished survey with a company to get SCADA back up
- H. Mission Springs Water District Amber Duff reported:
  - Provided detail on the Regional Water Reclamation Facility construction
  - General Manager is retiring; event on Aug. 3 at 5 p.m.
  - Brian Macy will be the interim GM
- Morongo Band of Mission Indians John Covington reported:
  - Chrom 6 comments appreciated; all will fall under the new MCL
  - PFAS is coming next; several class action lawsuits have been settled. He recommended testing
  - Lead and copper rule also coming

# REGULATORY ALERT: MEMBERS URGED TO PROVIDE COMMENTS ON DRAFT REGULATION FOR MAKING CONSERVATION A CALIFORNIA WAY OF LIFE

ACWA is urging its urban water supplier members to engage now with the State Water Resources Control Board on the development of its draft regulation for Making Conservation a California Way of Life. Under the "Proposed Text of the Regulation," urban retail water suppliers would be required to meet an agency specific urban water use objective starting in 2025, comply with annual reporting requirements and implement commercial, industrial and institutional performance measures.

ACWA has been raising concerns that the draft regulation, as currently proposed, would be infeasible for many suppliers and impose significant cost impacts. However, the State Water Board needs to hear directly from impacted members on their specific concerns and challenges.

Now is the time to influence the draft regulation before it is final as the State Water Board expects to adopt the regulation in summer 2024. ACWA is calling on members to take the following steps.

#### **Take Action Now**

- 1. Provide oral comments at the State Water Board's Oct. 4 Public Workshop being held at the Joe Serna Jr. CalEPA Building in Sacramento. ACWA is encouraging members to provide comments in person; however, there is a virtual option available if necessary. More information on what to include in your comments and information on how to provide comments during the workshop is available in an ACWA call-to-action flyer.
- 2. Submit your own comment letter to the State Water Board by Oct. 17 that highlights your agency's local success in advancing water use efficiency and shares your specific concerns with the feasibility and cost of implementing the proposed water use standards. Comment letters may be submitted via email to commentletters@waterboards.ca.gov with the subject line: Comment Letter Proposed Making Conservation a California Way of Life Regulation.

#### **Background**

In 2018, the Legislature enacted two key policy bills — SB 606 (Hertzberg) and AB 1668 (Friedman) — to implement a new framework for long-term water conservation and drought planning for water suppliers. The two bills provide new and expanded authorities, and requirements, that affect water conservation and drought planning for water suppliers, agricultural water suppliers, and small water suppliers and rural communities.

On Aug. 18, 2023, the State Water Board initiated the formal rulemaking for Making Conservation a California Way of Life and released draft regulatory text intended to implement AB 1668 and SB 606. More information on the draft regulation is available in ACWA's two-page fact sheet.

ACWA, its member agencies and coalition partners have been highly engaged on the state's pre-rulemaking efforts to inform the Making Conservation a California Way of Life Regulation. ACWA will continue to advocate for a long-term water use efficiency framework that is feasible and cost-effective and does not impair water agencies' ability to make long-term investments for climate resilience.

#### Making Conservation a California Way of Life

### ACWA URGES MEMBERS TO PROVIDE COMMENTS ON THE DRAFT REGULATION

ACWA is calling on urban retail water suppliers to engage now with the State Water Resources Control Board on the development of its draft regulation for "Making Conservation a California Way of Life." This is a critical opportunity to impact the draft regulation before it is final.



Highlight your agency's local success in advancing water use efficiency and share specific concerns with the feasibility and cost of implementing the proposed water use standards and Commercial, Industrial, and Institutional (CII) performance measures, including your agency's:

- History of advancing water use efficiency, including associated reductions in water use, dollar investment, duration to achieve savings and diverse programs;
- Expected percentage of reduced water use by 2035 under the proposed regulation;
- Anticipated cost impact with meeting your agency's water use objective, CII performance measures and reporting (e.g. cost of compliance, rate increases, affordability, etc.);
- Associated feasibility challenges with meeting your agency's water use objective and CII performance measure;
- Additional challenges if your agency serves a disadvantaged community; and
- Other unintended impacts, including concerns for heat island, shade trees, impacts to disadvantaged communities, affordability and enforcement.



#### **Simple Steps to Provide Public Comment**

ACWA encourages water suppliers to provide oral comments in person; however, there is a virtual option available if necessary. To provide oral comments:

- Fill out a virtual speaker card online. The online form and more information will be available at www.waterboards.ca.gov closer to the date.
- Join the meeting. Attend either in person at the Joe Serna Jr. CalEPA Building, 1001 I Street, Sacramento or virtually via Zoom. Note that if you are joining via Zoom, the Clerk will respond to your form with a password for the Zoom meeting.
- Provide oral comments. State Water Board staff will call speakers in the order that speaker cards were submitted. If you are participating via Zoom, you will be muted until it is your turn to speak.
   Typically, speakers are limited to three minutes.
