4. Presentation and discussion of City of Banning Chromium VI study Art Vela, Director of Public Works, City of Banning

Mr. Vela shared a presentation given recently to the Banning City Council regarding impacts and challenges of addressing Chromium VI (CrVI).

Mr. Jaggers added comments on options for mitigation and explained that the City and District are working together on options that provide maximum flexibility.

The Committee members commented on the regulations coming down from the state and the lack of consideration for the expenses to ratepayers.

- B. City of Banning Art Vela reported:
 - A \$6.2 million grant for the wastewater treatment plant expansion is in limbo
- C. Banning Heights Absent

- D. Beaumont-Cherry Valley Water District Daniel Slawson and Dan Jaggers highlighted:
 - Rate action Town Hall on April 10 and public hearing on April 24
 - 15 percent per year for five years to cover the projects with inflationary values
 - Significant increases in almost everything, and expected to continue to rise
 - Drilling some wells to mitigate Cr(VI)
 - Update of fire hazard zones
 - Limitations of water systems for fire
- E. Cabazon Water District Taffy Brock reported:
 - Waiting for the first heli-hydrant to be delivered
- F. City of Calimesa Absent
- G. High Valleys Water District Absent
- H. Mission Springs Water District Amber Duff reported:
 - The new wastewater treatment plant is operational
 - The South Coast Air Quality Management Board is moving forward on the removal of gas from homes (another regulation) and paying people to replace gas appliances with electric
- I. Morongo Band of Mission Indians Absent
- J. Riverside County EDA / Flood Control District Jason Uhley reported:
 - Prop. 4 included \$100 million for integrated regional water management for watershed climate resiliency projects. The County requested the funds be distributed through the local IRWM programs and recommended that the coalitions created could manage other money allocated through Prop. 4 as a way to maintain local control

- L. Yucaipa Valley Water District Joyce McIntire reported:
 - At the last Board meeting, there was discussion about wildfire coordination, prevention, preparedness and strategy. Looking into a joint powers authority
 - Regulations continue to proliferate

 - The agency is currently busy managing the heli hydrants, working on the gap funding program, and monitoring the Sites Reservoir and Delata Conveyance Project
